In 2021, we continued to pivot and shift through the challenges of the coronavirus pandemic—never imagining that we would still be navigating through such trying times! At Guthrie Cortland Medical Center, we remained determined in our commitment to provide the highest quality of care for our patients. In the Foundation, we gave a fond farewell to Executive Director, Deborah Nadolski, as she retired from over 18 years of service. Knowing we had "big shoes to fill", we conducted a search for her replacement, and recently welcomed Sheila Ossit as the new Director of the Foundation. We look forward to introducing Sheila in the months ahead.

We have been deeply moved by the community's unwavering support during this time of uncertainty. While it was necessary to cancel fundraising events and in-person interactions yet again, so many of you moved us forward--our individual donors, corporate sponsors, community fundraisers and granting organizations, continued to support a broad array of initiatives for the medical center. We are grateful and applaud the community's generous spirit over this past difficult year, and the nearly 130 years leading us to this moment.

Private Grant Offers Hope

The Saint Agatha Foundation's Hope Now Breast Cancer Fund provides individuals with financial assistance to help with the cost of breast cancer diagnosis, treatments, and other expenses related to recovery efforts. Since the program began in 2011, the fund has not only assisted 152 individuals with nearly \$160,000 in financial support, but it has given hope and encouragement to patients in need.

Employees Go "Above and Beyond"

Our employees continued to amaze us, as we finished The Healthcare Employees Reaching Out (HERO) Annual Giving Campaign. After embracing the challenges throughout the coronavirus pandemic, our employees gave of themselves even more with over \$39,300 pledged. 25% of the funds raised were designated for the Foundation's Employee Assistance Fund and the remainder will remain unrestricted to support upcoming needs at the medical center. Established in 2012, a total of \$148,000 has been disbursed to 161 employees during a time of personal financial crisis.

Opening of the Renzi Cancer Center at Guthrie Cortland

The much-anticipated Renzi Cancer Center opened to patients on October 4, 2021. The new state-of-the-art center, a 10.6 million dollar project, will provide a single, convenient point where patients can access multi-disciplinary care in radiation and medical oncology treatments without having to travel.

As we move to a new way of living in a post-pandemic world, your financial support is so important to continue the Foundation's mission to support the many programs and services at Guthrie Cortland Medical Center. We look forward to working together with you.

After three years now as Guthrie Cortland Medical Center, we continue delivering on the promise made in 2019— To invest in the health care needs of the community. We celebrate the changes that have already taken place and we are proud to share the improvements planned for the months ahead.

Opening of the Renzi Cancer Center and More Comprehensive Care to Come for Cortland

We were thrilled to open the Renzi Cancer Center in 2021, successfully fulfilling the need for comprehensive cancer care, close to home. To further meet that need, the hospital is currently completing renovations to its Imaging and Radiology Department, adding new technology to aid in the early diagnosis of cancer and other medical conditions. We will add the region's only PET CT later in 2022, a key component in the move toward stroke center designation, adding another layer of quality health care, locally.

Advancement of Technology for Patient Safety and Privacy

- Tablets are being added to patient rooms for better communication with family and for in-house caregivers to access information that helps patients make well-informed health care decisions.
- Online portal, eGuthrie.org, continues to grow, putting the power in the patient's hands, with the ability to schedule appointments, access health records, request prescription refills, message care teams and much more!

Improvements in Behavioral Health Care

Our Emergency Department regularly treats patients who require specialized care. To protect their privacy and keep them safe, we are building additional private rooms in the ED.

Mental health concerns are not usually solved with one visit to the ED. We have obtained grant funding to completely renovate our inpatient behavioral health unit in 2022/2023. The project will enhance the overall experience for patients while maintaining much needed beds within our region.

COVID-19 has been a challenge and we are grateful for the community's support over the last two years. Rest assured that during this time, Guthrie Cortland Medical Center has continued to work behind the scenes to meet the challenges ahead so we can continue to provide high quality care to the community we call home. 





Renzi Cancer Center Opens at Guthrie Cortland Medical Center

On the second day of September in 2021, Guthrie unveiled the Renzi Cancer Center at Guthrie Cortland Medical Center. The \$10.6 million dollar facility is revolutionizing cancer care in the region by bringing radiation and medical oncology services, as well as support services, together under one roof.

"Guthrie looks forward to enhancing the care provided to patients in the community and is excited to bring long-anticipated expansion of cancer services to Cortland," said Philip Lowry, MD, Chief, Hematology/On-cology, Guthrie Clinic; Director, Guthrie Cancer Center. "The new cancer center will further enhance and strengthen the care provided to patients, enabling them to receive care close to home."

The 10,825 square-foot facility includes: a state-of-the-art linear accelerator, ten chemotherapy infusion chairs, lab phlebotomy stations, an onsite pharmacy, exam rooms, procedure room, patient meeting room, and comfortable waiting areas.

Patients have access to a full array of surgical and diagnostic services. A comprehensive team of board-certified specialists work with patients through all aspects of their cancer journey. The new center provides supportive care programs in the same location where patients see their physicians.

"The Renzi Cancer Center is one of the greatest examples to date of Guthrie's partnership with the community to provide high quality compassionate care," said Jennifer Yartym, President, Guthrie Cortland Medical Center. "We are excited to see what started as an idea several years ago become a reality for comprehensive cancer care to patients and their families close to home."

The community has played a vital role in supporting the new cancer center. To date, the Cortland Memorial Foundation has raised \$2.77 million in support of ongoing services at the Renzi Cancer Center.

A one million dollar donation came from Mr. Nicholas Renzi of Cortland. It was Mr. Renzi's wish to honor the legacy of his late wife, Agnes, and help those battling cancer throughout the region. As a result, Renzi committed to matching the first million dollars in donations. "I am excited to support the Cancer Center knowing it will positively impact the lives of hundreds of people who could be cared for locally instead of traveling out of town, especially when they are medically challenged," Renzi said.
