Ken & Caroline Taylor: Moving Guthrie Forward Together

In 2019, a tour of the Emergency Department at Guthrie Robert Packer Hospital, given mid-expansion, made a big impression on Caroline Taylor – and inspired her and her husband, Ken, already dedicated Guthrie donors, to make another big gift.

Through The Kenneth & Caroline Taylor Family Foundation, the couple graciously donated \$1 million to Guthrie's Forward Together campaign. The goal of this campaign is to help Guthrie thrive during a time of enormous change. It is achieving that goal in several ways, including through the newly expanded and renovated Emergency Department at Guthrie Robert Packer Hospital – or, as it is now known, the Taylor Family Emergency Department at Guthrie Robert Packer Hospital.

“We appreciate the Taylor family's visionary leadership and their recognition of the importance of access to high-quality health care for our region,” says Guthrie Robert Packer Hospital President Joseph Sawyer.

A Long History of Service and Support

The Taylors' relationship with Guthrie goes way back. Ken was born at Robert Packer Hospital. One of the couple's children was born there as well, and one was born at Towanda Memorial Hospital, which is now part of the Guthrie system. The family has received quality care at Guthrie facilities throughout their lives.

“The physicians and staff that I've encountered have been very caring and considerate,” Caroline says. “They always have the best interests of their patients at heart.”

As president of Taylor Packing Co., Inc., located in Wyalusing, Pa., Ken appreciated being able to turn to Guthrie for care for the company's more than 1,100 employees.

“It was very important for us to have high-quality health care available nearby,” he says.

Ken also served on Guthrie Robert Packer Hospital and Guthrie Health boards for 25 years and currently serves as a trustee of The Guthrie Clinic, where he is an active member of its Investment subcommittee.

The Taylor family's roots in Northeastern Pennsylvania go back more than 200 years. Ken and Caroline created their foundation to support education and health care initiatives in the community that means so much to their family.

The couple, who now split their time between Wyalusing and Jackson Hole, Wyo., have given generously to Guthrie for 40 years. In that time, they have supported numerous projects at Guthrie Robert Packer Hospital and Guthrie Towanda Memorial Hospital, including the Kenneth and Caroline Taylor Surgical Reception Area at Guthrie Robert Packer Hospital.

A Transformative Gift

Decades of involvement with Guthrie, as well as a few hospital visits of their own, including after a serious bicycle accident for Ken, gave the Taylors an understanding of and appreciation for the critical role that high-quality emergency care plays in a rural area. But the tour Caroline received, led by Marc Harris, DO, System Chairman for Guthrie's Department of Emergency Medicine, really drove home for her just how essential that care is.

“I became acutely aware of the incredible number of patients they treat on a daily basis,” Caroline says. “Minutes matter for many patients, and having prompt access to high-quality care does make a difference.”

She and Ken were also impressed by Dr. Harris’ vision for Emergency Medicine at Guthrie. They are especially excited about the new Emergency Medicine Residency Program and its potential to serve as a pipeline for skilled emergency medicine physicians for years to come.

“That’s just an excellent opportunity for us to gain more and better emergency care,” Caroline says.

Inspiring Others to Give

The Taylors’ \$1 million gift served as the Forward Together campaign’s lead gift, and it has inspired others to give generously to the campaign as well.

Though supporting Guthrie has always been important to Ken and Caroline, they see donating, and inspiring others to donate, as even more essential in today’s world, in which demand for health care is increasing and government support is decreasing.

“Organizations like Guthrie are going to need more private support because they’re getting less public support,” Ken says, adding, “There’s no better way to give back than through the health care system that our community depends on. That’s why we’ve committed to the Forward Together campaign.”

A Running Tradition

Every year, before enjoying a Thanksgiving meal featuring turkey, mashed potatoes – and spaghetti – Michele Sisto and her family preemptively burn off some of those calories, and support a good cause, at the annual Guthrie Sayre Turkey Trot.



The family runs Yanuzzi's Restaurant, an Italian restaurant founded by Michele's grandparents in 1933. Michele's cousin Joe Yanuzzi manages the business now, but it is not unusual to see members of the extended family lending a hand when needed.

Working at Guthrie is also a family tradition. Michele has worked at Guthrie for 37 years and currently serves as Vice President and Controller of Finance. Her mom and her cousin Suzanne worked at Guthrie in the past, and her cousin Pete and daughter Maria currently work at Guthrie. Her cousin Katie, who is also a part owner of the restaurant, worked as a nurse at Guthrie for about a decade, and Katie's husband, Robert, is a surgeon at Guthrie.

Those connections to Guthrie, and an appreciation for the care family members have received from the health system, are two of the reasons the family is proud to support the Turkey Trot.

'Everyone's Cheering You On'

When Michele's family started participating in the Turkey Trot about seven years ago, it was just a few of them. Now their team boasts about 20 members. They have even been known to sport their own team shirts and the occasional turkey hat.

"It's a fun atmosphere," Michele says. "Whether it's your first time there or you've been there many times, everyone's cheering you on."

Over the years, the Turkey Trot has benefited many different Guthrie programs and services. Last year's event featured more than 900 runners and raised more than \$20,000 to benefit Guthrie's Cancer Care Fund. That cause was especially meaningful to Michele's family: Her father, now in his late 80s, received prostate cancer treatment at Guthrie. This year, Michele's cousin Suzanne was treated for cancer at Guthrie as well. She passed away in August, and Michele says the family is grateful for the excellent care she received during her treatment.

"We all feel very fortunate that we have this wonderful facility right here in our backyard," she says.

While this year's Turkey Trot is sure to look different, Michele says that is even more of a reason to get involved.

"I think the needs are greater than they've ever been because of COVID-19. So now, more than ever, I think we need to support events like this."

Preserving the Past and Inspiring the Future

When donors contribute to Guthrie, they do so with purpose. Guthrie practices careful stewardship to ensure that donor intent is respected, even over a long period. A good example of honoring donor intent is the guardianship of a special gift presented to Guthrie Robert Packer Hospital more than 75 years ago.

In 1944, Allan P. Kirby gifted a historical piece of art to the organization. “The Doctor” is a study painted in the late 19th century by British artist Sir Samuel Luke Fildes.

“This painting is one of the most famous images of the doctor-patient relationship. An attentive physician is deep in thought as he ponders his patient, a sick child asleep on two chairs,” explains Karen Kim, MD, Guthrie Gastroenterology and Hepatology, and a member of the committee charged with the painting’s restoration. “The doctor is portrayed as somebody all of us hope to have care for us one day. Somebody fully attentive, caring, and with 100 percent of his attention focused on us.”

The study informed Fildes’ Victorian masterpiece of the same title, which now hangs in the Tate Gallery in London. It was donated out of Mr. Kirby’s admiration for Dr. Donald Guthrie. “He is not only a wonderful surgeon, but he is a fine executive and great humanitarian,” Mr. Kirby said at the time he donated the painting. “These three qualities are seldom, if ever, found in one doctor.”

It was Mr. Kirby’s intent that the painting would be enjoyed by the hundreds of Guthrie patients and clinicians who would pass it every day. Preserving the painting became critical to respecting the intent of the gift’s donors in two ways. It ensured that the painting would continue to inspire future generations of clinicians in the art and practice of compassionate care. Undertaking the preservation also demonstrated to a new generation of the Kirby family Guthrie’s appreciation for their ancestor’s gift.

A monthslong restoration was undertaken last year that included meticulous cleaning and repair. The F.M. Kirby Foundation supported the restoration efforts.

“It is the F.M. Kirby Foundation’s honor to play a part in paying continued homage to the medical community at the Guthrie Robert Packer Hospital and The Guthrie Clinic who continue Dr. Guthrie’s legacy of compassionate care,” remarked S. Dillard Kirby, President of the F.M. Kirby Foundation.

“Though medicine has changed significantly over the last 100 years, the heart of what we as providers strive to give and what we know that patients want to receive has not changed: to provide compassionate care, that personal touch,” Dr. Kim explains. “‘The Doctor’ can now continue to inspire generations of clinicians and patients for years to come.”

S'more Reasons to Celebrate: Camps for Kids Reach Big Milestones

Summer camp is an essential childhood experience that should be possible for everyone – including kids grieving the death of a loved one and kids with special needs.



That is the idea behind two beloved local day camps. Both of these camps celebrated important milestones in 2019 and both are supported in part or in full by Guthrie and Guthrie Hospice.

Good Grief Day Camp

Good Grief Day Camp serves kids ages 6–18 who have lost a parent, grandparent, sibling, or other loved one. The camp has three goals: to show kids they are not alone, to help them memorialize the loved one they lost, and to teach them coping skills they can use long after camp is over.

The camp, which takes place in Standing Stone, Pa., celebrated its 20th anniversary in 2019. Some of the 459 children who have attended are family members of former Guthrie Hospice patients. This gives Guthrie social workers the opportunity to “walk the entire walk” with their patients, including caring for the children

who loved those patients, says social worker and camp co-founder Trudy Ventello, LSW.

“Those kids can honor their loved one just as we honored them when they went through the hospice program,” Ventello says. “That’s pretty special for me.”

Camp Sensation

Camp Sensation is an annual day camp where activities are designed for kids with ADHD, autism, Down syndrome, blindness, cerebral palsy, spina bifida, and other conditions. The camp is run by Guthrie Towanda Memorial Hospital’s Pediatric Therapy Clinic team and takes place at Towanda Area Elementary School. It celebrated its 15th year in 2019.

Each summer, 60 to 100 kids with special needs and their siblings attend the camp. Many kids come back year after year.

“Both the kids and the parents look forward to it all year,” says Tonya Garges, PTA, who has worked at Towanda Memorial Hospital as a Physical Therapy Assistant for 17 years and serves as a Coordinator for Camp Sensation. “Parents say, ‘We can’t get them out of bed – except when it’s time for Camp Sensation!’”

Happy Campers

Thanks to generous donors, kids attend Good Grief Day Camp for free, and kids attend Camp Sensation for just \$10 per child.

“It may seem like ‘it’s just a day camp, what’s the big deal?’” Garges says. “But it has such an impact on these kids’ lives.”
