Letter from the CEO



When our community gives to Guthrie, it's an expression of deep trust, a belief that we will always be there to care for people when they need it most."

At Guthrie, our promise is to deliver the highest quality care and the best possible experience to every patient, every time, regardless of location. We're here to stay, steadfast in our commitment to the people, families and communities of this region.

At a time when rural health care is increasingly under pressure, Guthrie is growing stronger. We've been part of this region for more than 115 years, and we're planning for the next 115 through enduring partnerships, clinical excellence and compassionate care rooted in innovation and service. Thanks to our donors, that future is already taking shape.

Investing in the Health of Our Communities

In the past year alone, donor support helped us expand access to care in more communities than ever before. From the relocation and expansion of Guthrie Tunkhannock to increased services in Cortland and the elevation of trauma care in Corning, we're meeting needs that previously went unmet. Welcoming Guthrie Lourdes Hospital in Binghamton into the Guthrie family has been a transformational step that strengthens care in that region and across our entire system.

Today, we are providing access to primary care appointments within one day 90% of the time, and access to non-urgent specialty care within five business days more than 60% of the time. These are the highest access levels in our history, at a time when other systems are cutting back. This speaks to Guthrie's enduring commitment to rural communities: expanding access when it's needed most, while never sacrificing the quality of care our patients deserve.

We've achieved all this while also treating more patients than ever before, investing in lifesaving technologies such as advanced imaging and linear accelerators for cancer treatment, and expanding critical services such as maternity care, including the launch of our mobile maternity care van. These investments are critical for access to preventive care such as mammograms. This past year we increased the number of mammograms performed by 40%, which resulted in an increase in cancers found in Stage 0 – the best possible time to find cancer and treat for positive outcomes.

Building on a Legacy of Impact

In 2024, we celebrated 10 years for the new Guthrie Corning Hospital location, a testament to the long-term vision that donor generosity has made possible.

Guthrie Corning Hospital started as a bold idea at a time when New York State wasn't building new hospitals. What began as a ground-up effort is now a regional anchor, offering advanced trauma care, surgical services and state-of-the-art robotics.

Our Guthrie Pulse Center has gained recognition nationally and from leadership across New York and Pennsylvania for establishing new benchmarks in remote care, virtual nursing and systemwide coordination. This innovative virtual hub allows us to keep patients close to home by connecting them with off-site specialists who might not otherwise be available on location. The Pulse Center has improved patient outcomes, such as a 40% reduction in patient falls through our virtual telesitters. It has also helped us further support clinical staff, enhancing our ability to recruit and retain nurses. We are continuing to add capabilities within our virtual hub, such as centralized caregiver security, making sure every caregiver feels safe and supported, so they can focus on what matters: our patients.

These are the kinds of advancements that philanthropy makes possible. When our community gives to Guthrie, it's an expression of deep trust, a belief that we will always be there to care for people when they need it most.

Keeping Care Local, Expanding Our Reach

Philanthropy doesn't just help us grow; it helps us grow with purpose. Whether it's expanding OB/GYN services in Ithaca, enhancing labor and delivery at Cortland, or

deploying mobile care throughout the region, we are fulfilling our mission to keep care close to home.

As we grow, we remain laser-focused on quality and safety. We've served the largest patient population in our history with the highest patient satisfaction in our outpatient settings and the lowest rate of hospital-acquired infections. We also earned top recognition for safety and clinical excellence, including our fifth consecutive Epic Gold Stars Level 10 achievement and the only Leapfrog 'A' hospital across an 11,000-square-mile region.

The Future Is Bright, and Grounded in Partnership

Looking forward, we remain committed to serving as the national benchmark for rural health care. This involves ongoing investments in advanced technologies, lifesaving equipment, caregiver development and local infrastructure. We are equally dedicated to maintaining a strong and well-supported workforce, an effort reflected by recognitions such as Forbes Best Place to Work in Pennsylvania, Best Employer for Women, and, for three consecutive years, Top Places to Work in Healthcare by Becker's Healthcare. Additionally, significant investments in provider well-being have earned us bronze-level Joy in Medicine recognition from the AMA. Our primary focus extends beyond accolades; it centers on ensuring that we have exceptional people capable of supporting our communities. To achieve this, we remain steadfast in enhancing competitive salaries, comprehensive benefits and robust wellness initiatives.

We are proud of how far we've come, and we are optimistic about where we're going. What gives me the most hope? The unshakable alignment between our mission, our caregivers, our donors and our communities, and our shared belief that everyone deserves high-quality care, close to home.

A Milestone With Meaning, and a Mission That Endures

In July 2014, a bold vision came to life with the opening of a state-of-the-art hospital built to serve Corning and the surrounding region with compassion, innovation and unwavering excellence. A decade later, Guthrie Corning Hospital celebrates 10 years of caring for the community it was designed to serve.

More than a modern replacement for the historic Corning Hospital that supported generations of families, the current facility's design centered on providing patient-centered care, close to home. With 65 private rooms, integrated technology and a welcoming atmosphere, the hospital has become a place where clinical expertise meets comfort and compassion. Over the past decade, Guthrie Corning Hospital has become deeply rooted in the lives of the people it serves, branching out to meet evolving community needs.

Milestones from the past 10 years include an expansion of outpatient services, advancements in robotic surgical capabilities and the achievement of provisional Level III Trauma Center designation in New York State, ensuring lifesaving care is close by when it matters most.

The hospital has made significant strides in wound care, imaging and pharmacy services, enhancing the range and quality of care available right in the heart of the community. Guthrie Corning Hospital has been recognized as a Primary Stroke Center by The Joint Commission and the American Heart Association and received AHA's 2024 Get With The Guidelines® Stroke Gold Plus Quality Achievement Award. In 2024, the hospital also received the Women's Choice Award® for Mammogram Imaging and was named a Five-Star Recipient for Treatment of Pulmonary Embolism by Healthgrades.

"For many years, Guthrie Corning Hospital has stood as a trusted partner in our community's health," said Paul VerValin, President of Guthrie Corning Hospital. "This milestone is more than a celebration – it's a reaffirmation of our promise to provide exceptional, compassionate care where it matters most: right here at home. Quiet Generosity, Enduring Impact

In 2024, Guthrie was honored to receive an extraordinary estate gift from Shirley Ellen (Williams) Giardina, whose thoughtful generosity will continue to touch patients and families for generations to come. Though Giardina didn’t share her intentions during her lifetime, she chose to make Guthrie part of her lasting legacy, ensuring that care and comfort will always be close to home.

A Life of Grace and Giving: Shirley Ellen (Williams) Giardina

Born in 1931 in Towanda, Pa., Shirley Giardina lived a life rich with creativity, movement and compassion. A 1950 graduate of Towanda High School, she founded the school’s Twirlers Club and Drum Majorettes, beginning a lifelong love of dance. After studying at Wilkes College, she went on to work in radio and later as an Arthur Murray dance instructor, teaching others the joy and confidence that dance brought her.

In 1959, she married Philip Giardina, and together they shared 50 years of partnership, friendship and community. The couple remained active in local dance clubs and shared a love of music, travel and time spent with family and friends.

When Giardina passed away in June 2024 at the age of 93, she left behind not only cherished memories, but also a lasting gift. Her estate included \$100,000 each to Guthrie Corning Hospital, Guthrie Robert Packer Hospital, and Guthrie Robert Packer Hospital, Towanda Campus.

Though she was not a donor during her lifetime, her generosity will have a lasting impact across the region she called home. Her planned gift will strengthen care across Guthrie’s hospitals, helping ensure that patients continue to receive compassionate, high-quality care close to home.

A Career Rooted in Service, a Legacy of Giving

After nearly four decades of service at The Guthrie Clinic, Russell Woglom, MD, is stepping into retirement with gratitude for the patients who entrusted him with their care, the colleagues who supported him and the opportunities that shaped his remarkable career. From his earliest days as one of just a handful of providers in Corning to his leadership as Chief Medical Officer, Dr. Woglom has been a steady presence through seasons of growth, challenge and change.



“It’s impossible to summarize 38 years,” Dr. Woglom says. “I’ve worked in so many roles: at the hospital, in the clinic and in leadership. My hope is that each one was impactful. When I think back, I just feel incredibly lucky to have had one employer for my whole career and to have been surrounded by so many great people. Health care can be a difficult and challenging environment, but Guthrie has always had more strengths than challenges, and I’m so proud to have been part of its enormous growth.”

The Heart of His Work: Patients

Though he’s held many titles, including internist, department leader, regional medical director and ultimately Chief Medical Officer, Dr. Woglom says his heart was always with his patients.

“The physician-patient relationship is unique. It’s a two-way street built on trust,” he says. “If you can earn that trust, patients will share things you might never otherwise know, and that trust allows you to help them change their lives and their health for the better. Over the years, many of my patients became friends. I’ve cared for some of them since the 1980s. Those relationships are what I value more than anything else. My patients have even helped me through hard times, like when my own parents were sick. Being their doctor was never a job; it was always a privilege.”

Dr. Woglom remained at Guthrie throughout his entire career because of a mission that continues to inspire him: to make a meaningful difference for every patient, every time.

“Most health care workers, at every level, simply want to make a difference,” he says. “That’s what kept me here. Consistency matters – serving patients in the same way over and over, with their needs at the center – because that’s what leads to the best outcomes. I hope that’s what I was able to do.”

Physician, Leader, Donor

In addition to serving patients and leading teams, Dr. Woglom also supports Guthrie as a donor.

“Guthrie has treated me very well as an employee, but more importantly, its contribution to our community has been extraordinary,” he says. “Why wouldn’t I want to give back? When I arrived in Corning in 1987, there were only 17 providers. Today there are more than 120 in the region. That’s pretty amazing for a rural community, and it only happens because of continued investment.”

Having seen firsthand how donor generosity improves care, Dr. Woglom says his support is a way of paying it forward. He points to upgrades to the women’s breast care center as one example.

“Donations to the center helped create a space that was warmer, less threatening, less stressful. If you can help women feel more comfortable coming in for screenings and care, that’s making a real difference.”

As a mentor, Dr. Woglom urges the next generation of Guthrie caregivers to let their values guide every decision.

“Always ask yourself: Is the patient truly at the center of this? Will it lead to the best possible outcome? If you live by that, you’ll always make a positive impact,” he says.

Though he will miss his colleagues and patients, Dr. Woglom is deeply grateful.

“I’ve exceeded my greatest dreams,” he says. “I was given opportunities I never even imagined. I owe that to the clinic, and I’ll be forever grateful for the relationships I’ve built and the progress I’ve seen.”

As a physician and a donor, he remains confident in Guthrie’s future.

“No one can predict exactly what’s ahead, but I’m certain Guthrie will continue to thrive. The organization is committed to embracing the most modern technologies and services to provide patients with the best possible care, and I believe Guthrie will be here, serving these communities, well into the future.”

Carrying Forward a Family Tradition of Compassion

For more than a century, the McNeil family has been part of the fabric of Cortland: building businesses, creating jobs and giving generously to strengthen the community they've always called home. From their early days as local entrepreneurs to their ongoing partnership with Guthrie Cortland Medical Center, the McNeils have built a legacy defined by hard work, humility and heart.

"I'm a third-generation Cortland resident," says Dan McNeil, President of McNeil & Co., a specialized risk management and insurance company. "My grandfather came here in the early 1900s, and my parents were both products of the Depression. My father would be the first to say that they lost everything. He only had a chance to go to college through the G.I. Bill, so he went to war and then returned to Cortland, where he married our mother and raised us. The Cortland community has been very good to our family, and we've always felt a responsibility to give back in kind, to return the generosity we've received."

Honoring Family and Community

In 2024, the McNeil family was recognized at Cortland Memorial Foundation's Harvest of Gold event, a celebration of their longstanding generosity and support of the Foundation and Guthrie Cortland Medical Center. For Dan McNeil, it was a meaningful but humbling experience.

"We're generally low-key people. We've always preferred to stay behind the scenes," he says. "But my mother [Rose] and my father [Daniel], who passed away in 2018 and 2024, both received incredible care at Guthrie Cortland, and this was our way of saying thank you to the people who took such good care of them. It was truly an honor."

That spirit of gratitude has shaped the family's enduring relationship with Guthrie Cortland Medical Center and the Cortland Memorial Foundation, supporting initiatives across the hospital, from the Renzi Cancer Center to the Emergency Department and beyond.

"The first time I gave to the hospital was probably 15 or 20 years ago," McNeil recalls. "We contributed to the emergency room renovation, and a bay was named after my company, which insures ambulance services. I've spent my career traveling to other communities like Cortland, and very few towns our size have a facility like this. It's an incredible asset, and we need to protect it."



Supporting Care Close to Home

The McNeils' support of the Renzi Cancer Center holds personal meaning as well. Dan's late sister received treatment for cancer that required frequent travel to Memorial Sloan Kettering Cancer Center in New York City, a journey that not all patients can make.

"That experience really opened our eyes," he says. "We wanted to help people who can't travel for care. There are so many who need those services close to home. If our support can help make that possible, that's what matters most. It's all about the people: our friends, our neighbors, our community. Without the people, what do we have?"

That belief in caring for others, deeply ingrained by his parents, continues to guide Dan.

"My dad was always one to open the door for someone, to make sure no one went hungry," he reflects. "He taught us that no one is better than anyone else, no matter their level of success, money or awards. Those are the values we were raised with, and that's the foundation for everything we do."

A Legacy of Leadership and Loyalty

Though McNeil & Co. has grown far beyond its local roots, Dan McNeil's sense of loyalty to Cortland has never wavered.

"I've always been proud to be 'Dan from Cortland,'" he says. "Even when I moved away for college and the start of my career, I knew I'd come back. It's the people here that make this community so special."

That philosophy extends to the way he runs his business. "I think of it as a three-legged stool," he explains. "My customers, my colleagues and my community – those are my three C's. Every decision I make, I think about how it affects all three. They're equally important, and I want to take care of each of them."

A Call to Care

Dan hopes his family's story inspires others to get involved in sustaining local health care. "Besides the fact that it's medical care you or your family may need desperately someday, Guthrie Cortland really sets this community apart," he says. "We shouldn't take it for granted. Supporting it, with whatever amount you can, makes a difference. Every gift helps keep care local and strong."

As Cortland continues to grow and evolve, the McNeil family's legacy serves as a reminder that generosity, at its heart, is about connection.

In 2024, he pledged \$1 million in support of Guthrie's newest investment in Cortland: the Guthrie Cortland Renzi Health Campus, a 32,000-square-foot facility designed to bring together imaging, lab services, primary care and specialty care, including orthopedics, general surgery, plastic surgery, obstetrics, gynecology and pain management, all under one roof. In his words, it was a "major step in making The Guthrie Clinic a leader in the Cortland community." His gift was soon matched by community donors, a powerful testament to his role as both catalyst and cornerstone in Cortland's health care progress.

Guthrie President and CEO Edmund Sabanegh, MD, MBA, said it best last October, "Words cannot express the gratitude we feel for Nick Renzi. A donation of this magnitude, in our region, stretches extremely far. We are proud to have Mr. Renzi's name next to ours."



Guthrie Lourdes Hospital also continues to extend its reach through mobile health units that bring mammography, dental care and primary medical services directly into the community.

This integration allows Guthrie to deepen its presence across 14 counties in New York and Pennsylvania and ensures patients throughout the Southern Tier have access to coordinated, high-quality care close to home. Together, the system now includes nearly 1,000 providers and 10,000 caregivers working in a shared mission of service.
